Alternative terms and conditions of the client shall only be valid if they have been confirmed in writing by Friedrich Depke Naturheilzentrum e. K. Oral agreements and side agreements shall also require written confirmation.

2. Enrolment

Enrolment shall take place on the provided form. You will subsequently receive confirmation of your application. The number of participants is limited.

3. Prices/Payment

The seminar fees are final prices, which include 19 % VAT. Travel and accommodation costs are not included in the seminar fees.

Payments outside the European Payments Area will only be accepted by us if these are actioned as OUR transfers, i.e. all bank fees (for senders and recipients) shall be borne by the party effecting the transfer. Please compare so as to ascertain whether a transfer via TransferWise (www.transferwise.com) is more favourable.

The allocation of the seminar places shall follow in the order of receipt of payment. Should the transfer of payment have only been effected when the seminar was already booked out, we will immediately inform you thereof and your seminar fees will be reimbursed.

4. Accommodation

Accommodation in different price categories is available in Kemmenau and in Bad Ems which is 5km away. We will be happy to send you a list of suitable accommodation options.

5. Cancellation

In the case of cancellation of enrolment up to 14 days prior to commencement of the seminar, already paid seminar fees will be reimbursed. Thereafter, there will be the option of enrolling a replacement participant or of repeating the seminar at a later date.

If participation in a seminar that has already commenced must be broken off, there shall be no entitlement to reimbursement. The missing time may be made up in a later seminar.

In the event of cancellation of the seminar by the organiser due to illness, too few participants, Act of God or for other reasons, all amounts paid up to that point in time shall be reimbursed. Further compensation claims shall be ruled out.

6. Miscellaneous
